Did you know that allowing a patient to use one of their own inhalers during an asthma attack can actually hurt them? Shortness of breath calls are among the most common, and lethal! Most providers are used to using one or two medications as bronchodilators, but emergency respiratory pharmacology can be easily divided into three mechanisms for optimal treatment. Learn which medications correct specific respiratory pathology and which combinations can be deadly if you don't know about them. This session has useful, practical information for both EMTs and Paramedics. At the conclusion of this session you will be able to list the three most common pathologies occurring during a shortness of breath call; describe why each of the three classes of respiratory medications are used in prehospital medicine compared to one another; and differentiate between mucolytics, antitussives, and expectorants.

At the conclusion of this session, participants will be able to create a list of differential diagnosis based on the presenting problem and assessment findings; determine a treatment plan based on assessment findings of unusual prehospital cases; and appreciate the in-hospital diagnostic tests and treatments prescribed to patients.
