Board Elections

Board members will be elected by ballot by majority vote of the Chapter membership at the Chapter's [Annual Meeting](#) on **June 7, 2023**.

- **Three (3) Board Members will be elected by the membership to serve a three-year term.**
 - Current Board members with expiring terms are eligible for re-nomination and re-election.
 - Their terms of office will begin at the close of the Annual Meeting at which they are elected.

Councillor Elections

Councillors will be elected by ballot by majority vote of the Chapter membership at the Chapter's [Annual Meeting](#) on **June 7, 2023**.

Councillors represent the Ohio Chapter on ACEP Council. [ACEP Council](#) is the deliberative and representative body that meets once a year for two days prior to the College's annual Scientific Assembly (2023's Scientific Assembly, ACEP23, is planned to be held in Philadelphia, PA on October 7 & 8, 2023). The Council votes on resolutions, elects members to the National ACEP Board of Directors, and ensures grassroots involvement in the democratic decision-making process.

- **Nine (9) Councillors will be elected by the membership to serve either a 1-year or a 2-year term.**
- Terms will be assigned following the 2023 Annual Meeting.
- Current Councillors with expiring terms are eligible for re-nomination and re-election.

Board Candidates



Laurel Barr, MD, FACEP; Board Candidate *(Columbus, Ohio)*

Dr. Barr became active in Ohio ACEP advocacy through Hill Day over the last several years. She recently expanded her involvement with Ohio ACEP through the 2022-2023 Leadership Development Academy. Dr. Sanders has practiced community emergency medicine since completing his residency at The Ohio State University Medical Center. While studying at Loyola, Dr. Squier earned minors in Bioethics and Business Administration. He then returned to Toledo to attend the University of Toledo College of Medicine for his medical degree. Seeking to continue training for emergency medicine in arguably the most beneficial climate for the specialty, Dr. Squier stayed in Ohio and trained at Akron General

Medical Center, the first community-based emergency medicine residency program in the country.
